Lights & Siren Collaborative

We are over halfway through the L&S Collaborative, and it is still going strong! This national quality improvement collaborative is focused on improving NEMSQA Safety-01 and 02 measures on use of lights and siren and has 50 participating EMS agencies from across the country.

These 50 agencies have participated in two 4-hour learning sessions during which teams discussed successes and challenges and planned the next steps in their improvement journey. Collectively, the participating teams have conducted 69 PDSA cycles, entered over 7,000 data points, and shared over 60 resources! They have engaged internal and external stakeholders to assess attitudes and beliefs around L&S in preparation for change, implemented modifications to dispatch protocols, and have seen measurable reduction in their use of lights and siren during response and transport.
